| <p>1 All members must read and understand the terms and conditions herein.</p> <p>2 All members are to abide by the NSW Supra Club Incorporated Rules and it is the responsibility of all members that they have fully read and understood the Rules.</p> <p>3 All members are required to abide by all federal and state laws and regulations. It is the sole responsibility of the member to know these laws and regulations.</p> <p>4 Any member found to have broken the laws and regulations of any authority will personally responsible to the relevant charges and fines, as well as disciplinary action from the Club Committee. The NSW Supra Club reserves the right to report any member to the relevant authority, at the sole discretion of the Committee.</p> <p>5 No member is to act in a way that may negatively affect the Club or its reputation, in any way.
